## **INSURANCE**

**Double Bridges Aviation, LLC. is covered by all proper insurances. While this insurance protects Double Bridges and our aircraft, it does not protect you from pilot error liability. If you are a student flying with Double Bridges Aviation LLC., you MUST sign a Hold Harmless Agreement stating that you will be personally responsible for any damages incurred as a result of pilot error. A copy of this Agreement is attached.**

**If you are a licensed pilot and renting aircraft at Double Bridges Aviation LLC., Non-Owned Aircraft Liability Insurance (Renter's Insurance) is required. You must provide a copy of your proof of insurance along with your coverage limits for our files.**

**Double Bridges Aviation, LLC. has no connection to any insurance company and has no preference as to where you purchase this coverage. However, you must have it in order to rent our aircraft.**

## ***Indemnity & Hold Harmless Agreement***

**To Whom It May Concern:**

**Attention all Instructors and Students:**

**We take pride in the continuous care and maintenance of all our aircraft here at Double Bridges. We are careful to keep up with routine service, as well as day to day problem oriented repairs and major maintenance as required for aircraft rental by the FAA.**

**No matter how hard we try to keep ahead of the problems, it is just impossible. The law of average says that sooner or later, the chances are good that you will have some type of problem with one of our aircraft. We ask that you be patient and cooperate with us in solving it. If it is a minor thing that you write up in the discrepancy log, please also bring it to the attention of someone here in the office. That way, it will not slip by unnoticed.**

**If your flight is cut short by some type of problem, be sure to record your hobbs meter time at that point, as you will be responsible for payment from the time out until the time of the problem.**

**The above instructions also apply if you are on a cross country flight and have a problem and cannot get back to Double Bridges. Your obligation for aircraft rental payment stops when the flight stops due to malfunction of the aircraft. We will make all efforts humanly possible to recover you and the aircraft as soon as possible.**

**Double Bridges will not be responsible for any expenses that you personally incur while the aircraft is down away from here. That includes, but is not limited to; overnight room and board, car rental and meals.**

## **RENTAL SHEET INSTRUCTIONS**

**A rental sheet must be filled out EACH time that you fly an aircraft at Double Bridges Aviation, LLC. There are NO EXCEPTIONS! The rental sheet should have your full name, address and phone number, the Hobbs in and out readings and a total of the time flown. Each aircraft book has a spreadsheet containing the calculations you will need to fill out your charges for the flight time and rental tax due for each flight.**

**Upon completion of your flight, the aircraft information book along with the rental sheet, fuel receipts and payment should be turned into the office or placed in the drop box provided.**

**If you are a VA Student, the instructor's name should be included along with the in-flight instruction and ground instruction charges. The Instructor's fees must also be included in your payment to Double Bridges Aviation, LLC. This applies to VA Students ONLY.**

**All aircraft are rented "wet". You will be given credit for fuel purchased off the Enterprise Airport at the current airport rate. You must turn in your receipt to receive credit.**

**Arrangements must be made in advance and special permission granted in order to keep any aircraft overnight!**

**All checks for aircraft rental should be made payable to: Double Bridges Aviation, LLC.**
